# WICULS 2016 Post-Summit Workshop For Young Muslim Student Leaders

### INTRODUCTION

The WICULS 2016 Post-Summit Workshop for Young Muslim Student Leaders is a 3-day workshop designed especially for university student leaders who have maintained full attendance at the WICULS 2016 Summit. In addition, this workshop is also organized to gather youth community leaders around ASEAN to discuss current scenarios of community education and higher education in their respective nations. It is expected that the youth leaders will share relevant inputs on their active contributions toward the development of the communities through the initiation of various programs and projects at various community levels. The workshop will draw on the experience and perspectives of the young leaders in articulating a future for higher education underpinned by the scenarios in their respective localities.

Participants from the Summit will come away with awareness on the issues afflicting the Muslim ummah and an understanding on the causal factors for the decline in the capacity of universities to bring about societal change and development particularly for the Muslim ummah; while identifying the possible solutions. As future leaders of universities and in the higher education sector, the young leaders are expected to use the knowledge acquired in the Summit, as the basis for discussions in the workshop in order to envision scenarios of higher education in the future.

This Post-Summit Workshop for Young Muslim Student Leaders will be conducted by Prof. Dr. Sohail Inayatullah, an expert in the field of Future Studies from Tamkang University, Taiwan.

### PARTICIPATION

The workshop is open to 2 participants each from the 10 ASEAN member countries and 10 participants from Malaysia.

Interested Participants from ASEAN countries are invited to submit an essay of about **4,000 – 4,500 words in length and must be contained within 20 pages including tables, figures, and references**. The article must discuss their own traditional villages to show that these villages are still alive and self-sustaining although much in need of development. Our interest is first to get a fair and compact description from sources that are reliable and scholarly in nature. This will help in promoting balanced development for the future of all citizens, mindful of preferences relating to the kind and nature they desire most of all.

As a guide, papers must be between 4,000 and 4,500 words in length and must be contained within 20 pages including tables and references. All papers must include an Abstract and conform to the following generic format: introduction, literature review, methodology, findings/discussion, conclusion/implications and references.

Please use the checklist provided below to ensure that your paper meets the requirements prior to publication. Interested applicants must send the paper in **Ms Word Format** and not as a Pdf file.

- ✓ Papers must be written in A4 paper size
- ✓ Title of the paper is no more than 15 words, centered and in 16pt font
- ✓ Author(s) name(s) appear below paper title in 14pt font and centered
- ✓ Leave two empty lines before and after the name(s) of the author(s)
- ✓ All text Arial font
- ✓ Section/sub-titles are in numbered sequentially
- ✓ Leave one empty line before and after each section/sub-title
- ✓ Line spacing throughout paper is single-spaced (no double spacing please)
- ✓ Abstract is in italics, 10pt Arial font and justified
- ✓ Keyword is indicated after Abstract
- ✓ All text is in 12pt. Main headings in bold and 14pt Arial font and all sub-headings in bold and 12pt Arial font
- ✓ Author(s) affiliation, address and email is provided at the bottom of the Authors name
- ✓ Figures, tables and charts are included within the body of the paper
- ✓ All text is justified
- ✓ Single empty line between two paragraphs
- ✓ End notes are included before reference section – if applicable. (Please do not use footnotes)
- ✓ Paper has been checked for grammar and spelling
- ✓ References provided at the end in alphabetical order - References should be completed and in APA style
